## THE OWNER/APPLICANT HEREBY AGREES:

- 1) To provide, erect and maintain all necessary barricades, lights, warning signs and other devices to safeguard traffic properly while the work is in progress.
- 2) That the roadway will at no time be closed to traffic.
- 3) To obtain and have delivered to the site any culverts and/or drainage structures which may be necessary for proper drainage.
- 4) Entrance location should be situated, so as to maximize site distance.
- 5) Entrance shall be constructed in such a manner, as to not direct drainage onto the roadway (approach to town way should be level or at a negative grade).
- 6) Care shall be taken, so as to not damage the culvert pipe during transport and installation.
- 7) Clean, well graded gravel shall be used as backfill around culvert pipe.

- 8) Rip-rap shall be used at inlet and outlet of culvert pipe, leaving a minimum of two feet of exposed culvert pipe, beyond the rip-rap, on each end.
- 9) Provide ditching, as necessary, to ensure proper flow entering and exiting culvert pipes. Also, stabilize the ditch line, as necessary.
- 10) Entrances not meeting the specified criteria will be removed, as necessary, to correct any problems.

FURTHER CONDITION OF THE APPLICATION: shall be that the owner/applicant shall well and truly pay all damages, fines and penalties for which he shall become liable and shall indemnify and save harmless said Town of Woolwich against all suits, claims, damages and proceedings of every kind arising out of the construction and maintenance of said driveway approach, including snow removal.
